### ARTICLES OF INCORPORATION FOR SANDLOT PLUMBING, INC.

The undersigned, pursuant to the Florida Business Corporation Acadopts the following as the Articles of Incorporation for SANDLOTER PLUMBING, INC:

### ARTICLE I (Name and Mailing Address)

The name of the corporation is SANDLOT PLUMBING, INC., and its ∞ mailing address is 3124 Crowder Street, Port Charlotte FL 33980.

### ARTICLE II (Duration)

The duration of this corporation is perpetual and its existence shall commence on the date of execution of these Articles.

# ARTICLE III (Purpose)

This corporation is organized pursuant to Chapter 607 of the Florida Statutes for the purpose of providing plumbing contractor services and conducting any other lawful business in the State of Florida. This corporation shall have the power to buy, own and sell real property, to engage in such other activities as are incidental to or connected with the purposes stated above and to engage in and conduct any and all other lawful business.

### ARTICLE IV (Capital Stock)

This corporation is authorized to issue 10,000 shares of common stock with a par value of \$1.00 per share.

# ARTICLE V (Initial Registered Office and Registered Agent)

The street address of the initial registered office of this corporation is 2248 First Street, Fort Myers, Florida 33901, and the name of the initial

#### ARTICLE VI (Preemptive Rights)

Every Shareholder, upon the sale by the corporation for money consideration of any new stock of this corporation, shall have the right to purchase his pro rate share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VII (Initial Board of Directors)

This corporation shall have two directors initially. The number of Directors may be either increased or diminished from time to time by a majority of the shareholders present in person or by proxy at any annual or special meeting of the shareholders but shall never be less than one director nor more than seven directors.
