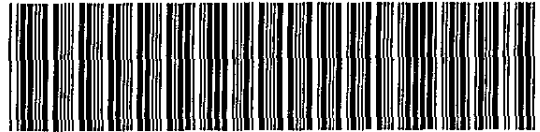

ARTICLES OF INCORPORATION

FENCE BY THE FOOT, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is Fence by the Foot, Inc.

ARTICLE II - DURATION AND COMMENCEMENT

The corporation shall exist for a period of perpetual existence, commencing upon the approval by the Secretary of State.

ARTICLE III - PURPOSE
