

ARTICLES OF INCORPORATION

The undersigned subscriber of these Articles of incorporation, a natural person competent to contract, hereby applies to form a corporation under the laws of the State of Florida.

FIRST: The name of the corporation is: MDS DISTRIBUTORS OF MIAMI CORP.

SECOND: The corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida, including, but, not limited to the distribution of health and beauty aids, including, but, not limited to the distributor of health and beauty aids.

THERD: The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be 500 shares, having a ONE DOLLAR (\$1.00) par value each.

All of the aforementioned stock is to be issued as fully paid for and is exempt from assessment.

The capital stock may be paid for in property, labor, or services at a just valuation, to be fixed by the incorporator, or by the board of directors at a meeting called for such purpose, or at the organization meeting.
