ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED SUBSCRIBERS to these articles of incorporation, each a natural person competent to contract hereby, associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

The general nature of the business and the objectives and purposes proposed to be carried on, are to engage in any business or activity permitted under the laws of the United States and the State of Florida and more particularly carpentry work.

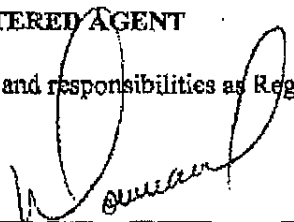
