## **STATE OF FACTS**

#### Incident Details:

I, Jorge A. Davila Miguel, hereby report the unauthorized removal of my name from the official corporate registry of Bravo Communications Corp. My name was illegally deleted from the records that guarantee my ownership rights in the corporation, which is registered under Document Number PO4000136337.

The unauthorized action was carried out by Damian V. Davila, who did not have the legal authority to remove my name from the corporate registry. I suspect this was done with ill intentions and surely without my knowledge or consent. I have already submitted Articles of Correction to Florida Department of State, Division of Corporations, in order to correct a previous amendment submitted in error.

I am the incorporator and sole owner of Bravo Communications Corp since its filing in September 30, 2004. I have never granted, sold or transferred legally any Bravo Communications Corp to Damian V. Davila.

### Legal Implications of the Incident:

- 1. Loss of property rights: The removal of my name from the registry means I could lose my rights to the assets of the corporation and may no longer have the authority to act on behalf of the company.
- 2. Legal Actions: As a result of my name being removed from the corporate register, I will face difficulties in presenting or defending legal actions on behalf of the corporation, which impacts my ability to protect my interests.
- 3. Financial Impact: This unauthorized removal may severely affect the corporation's ability to operate and generate income, potentially leading to significant financial losses for me and other stakeholders involved.
- 4. Reputation Damage: This action also endangers my personal and business reputation, as it undermines the trust that clients, partners, and the public place in me and the corporation.

### Requested Actions:

I am filing this report to bring attention to this illegal action, and request that the authorities at SunBiz, -- Florida Department of State, Division of Corporations official registry in Tallahassee, Florida-- do not allow or publish any other amendment or document coming from Damian Davila under Bravo Communications Corp, without my written consent. I am asking Florida Department of State, Division of Corporations to restore my name, title and ownership in Bravo Communication Corp.
