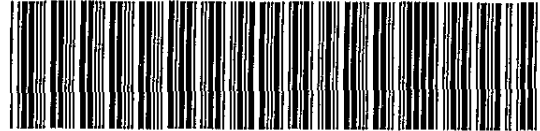

**ARTICLES OF INCORPORATION OF**

**POWERTeam, INC.**

**ARTICLE I**

**NAME**

The name of the corporation is POWERTeam, INC.

**ARTICLE II**

**DURATION AND COMMENCEMENT OF EXISTENCE**

This corporation shall commence on the date of filing with the Secretary of State. This corporation shall have perpetual existence.






