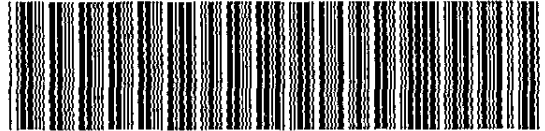

**ARTICLES OF INCORPORATION
OF
BUILT-RITE U.S.A., INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is BUILT-RITE U.S.A., INC., and the principal address and principal place of business is 625 PINELLAS STREET, UNIT B, CLEARWATER, FLORIDA 33756.

ARTICLE II - REGISTERED OFFICE AND AGENT
