ARTICLES OF INCORPORATION

OF

The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be **HOME POWER OF FLORIDA, INC.**

ARTICLE II

The principal place of business and mailing address of this corporation shall be 12260 SW 49 COURT, COOPER CITY, FLORIDA 33330.

ARTICLE III

This corporation's existence shall be effective on the date of subscription of these Articles, and the corporation shall have perpetual existence.

ARTICLE IV

The general purpose for which this corporation is organized is to manufacture, purchase, and sale of residential and commercial energy power units and to transact any or all lawful business permitted under the laws of the State of Florida.


ARTICLE IX




