### ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: TEX RHODES CONSTRUCTION, INC., with initial principal offices located at 2320 Palm Valley Road, Ponte Vedra Beach, FL 32082.

#### ARTICLE II - DURATION
