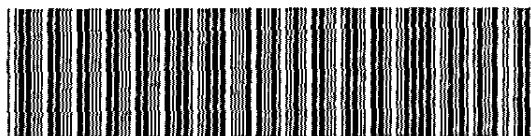

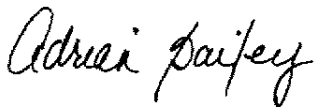

In compliance with Chapter 607 and/or Chapter 621, F.S. for Profit the following corporation is organized:

**I.  
Name**

The name of the Corporation is **PM LOGISTICS, INC.** hereinafter referred to as the "Corporation."

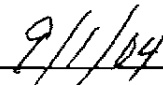
