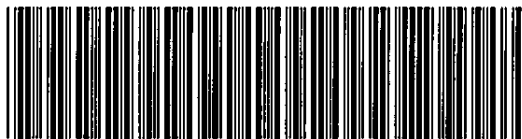

**FINAL JUDGEMENT**

THIS ACTION was tried before the Court on August 8, 2007 and on the evidence presented,

IT IS ADJUDGED that Fierce Enterprises, Inc., a Florida corporation is hereby dissolved pursuant to this Court's powers under Florida Statute § 607.1430 and the Court finds that such dissolution is warranted based on a finding that the directors are deadlocked in the management of the corporate affairs and that the shareholders are unable to break the deadlock and irreparable injury to the corporation was threatened or suffered.

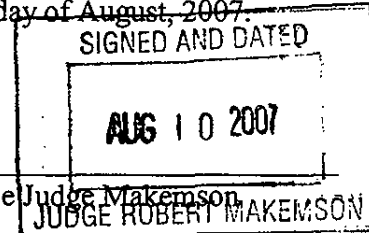
IT IS FURTHER ADJUDGED that any potential creditor of the corporation shall file a claim in this case with the Clerk of Court within four (4) months from the date of this Final Judgement.

IT IS FURTHER ADJUDGED that MARY L. BALTES shall recover from STUART MALONE the sum of Forty One Thousand Eight Hundred Ninety Three Dollars and Forty Seven Cents (\$ 41,893.47) that shall bear interest at the rate of seven percent (7%) per year for which let execution issue.

IT IS FURTHER ADJUDGED that the Court will reserve jurisdiction to determine any

entitlement and amounts of attorney's fees owed to Defendant MARY L. BALTES pursuant to  
Florida Statute § 607.1431 (4).
