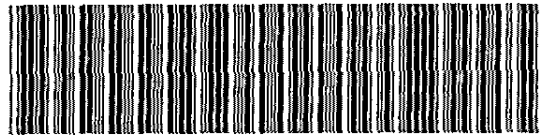

The undersigned desiring to form a corporation for profit, does hereby certify:

Article 1: The name of the corporation shall be Personal Services of Broward, Inc.

Article 2: The place in the state of Florida where the principal office of the corporation is to be located is 2311 NE 26<sup>th</sup> Street, Lighthouse Point, Florida. 33064-8350.

Article 3: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be formed under the Florida Code. Specifically, but not limited to accounting, financial, personal services, sales, and management consulting.

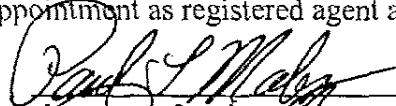

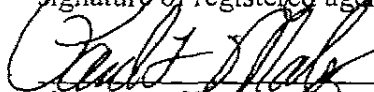
