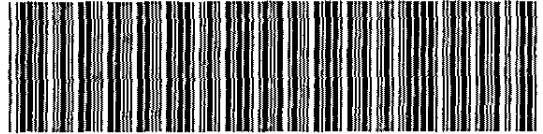



ARTICLE ONE

The name of the corporation is BUDDY'S APPLIANCE REPAIR, INC. The principal office of the corporation is 5723 150TH Avenue N., Clearwater, Florida 33760.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

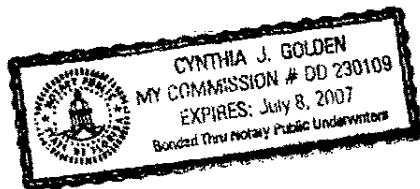


