

ARTICLES OF INCORPORATION OF AMERICAN AVIATION LIGHT PANELS, INC.

ARTICLE I

NAME, PRINCIPAL OFFICE, AND MAILING ADDRESS

The name of this corporation is AMERICAN AVIATION LIGHT PANELS, INC. The corporation's initial principal office and mailing address are located at 8570-113 Phillips Highway, Jacksonville, Florida 32241.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in and transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.
