ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
DOCK BUILDERS, INC.

DOCK BUILDERS, INC., a Florida corporation (the "Corporation"), organized and existing under the laws of the State of Florida, hereby certifies as follows:

Pursuant to unanimous written action of all of the shareholders and all the members of the Board of Directors of the Corporation in lieu of a special meeting, which vote was sufficient for approval, the following resolution was adopted on November 8th, 2004, amending the Articles of Incorporation:

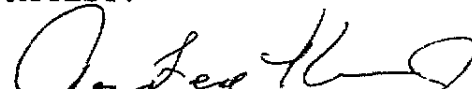

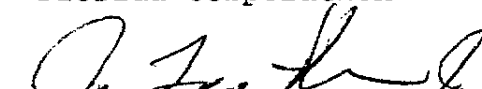
