# ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

### ARTICLE I - NAME

The name of this corporation is:

Palmetto Beach Realty Inc.

### ARTICLE II – ADDRESS

The street address of the initial registered office of this corporation is 3980 Overseas Highway, Marathon, Fl 33050. The name of the initial registered agent of this corporation at the aforesaid street address is: James N. Massaro.

### ARTICLE III – NATURE OF BUSINESS
