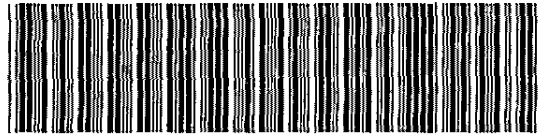

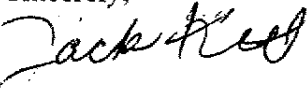

ARTICLE I - NAME

The name of this Corporation shall be:
Big Sur Technology Services, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 09/25/04.

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT

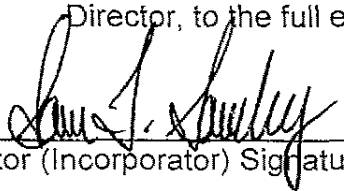

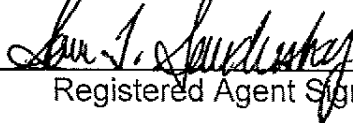

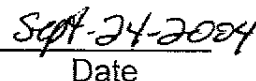
