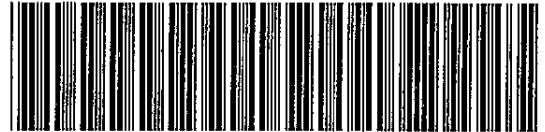



ARTICLES OF INCORPORATION
OF

ARTICLE I • NAME

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X • POWERS




