
Article IX - Indemnification

These Articles of Incorporation may be amended in any manner and by way of any procedure provided by law.



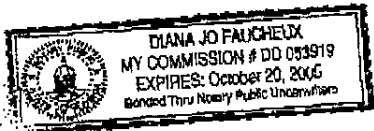
