

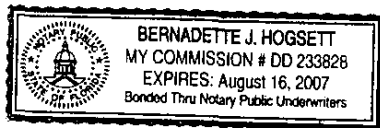
1. Saintony Virgile is the President of VIRGILE ALL PURPOSE, INC., a Florida corporation, (hereinafter "Corporation").

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
