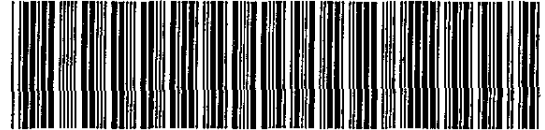



OF

ARTICLE I. NAME

The name of this corporation is
MOBILE MAINTENANCE BY B., INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.


