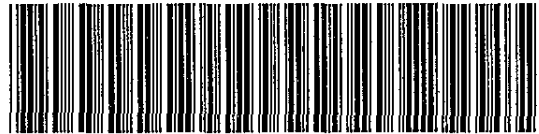



**ARTICLES OF INCORPORATION
OF
TAKE CTRL COMPUTERS, INC.**

ARTICLE I: The name of this corporation is **TAKE CTRL COMPUTERS, INC.**

ARTICLE II: This corporation shall have perpetual existence.

ARTICLE III: This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV: The maximum number and class of shares of capital stock which this corporation is authorized to have outstanding is one hundred shares of common capital stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V: The initial principal office of this corporation shall be at 877 Stockton Street, Jacksonville, Florida 32204, and the name of the corporation's initial registered agent at that address is CHRIS VARNEDOE.

ARTICLE VI: Initially, this corporation shall have two members on the Board of Directors, and the corporation shall have the authority to operate with not less than one member on the Board of Directors. The following are the names and addresses of the initial member of the Board of Directors:

ARTICLE VIII: The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.


