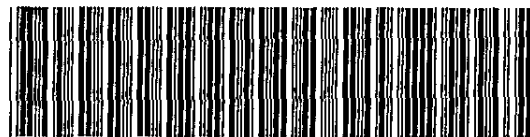

OPTION TO BE RE-ELECTED.




