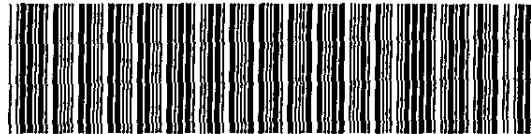

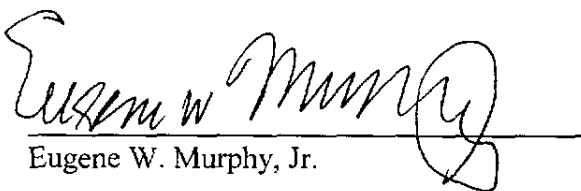

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act (the "Act"), does hereby adopt the following articles of incorporation for such corporation:

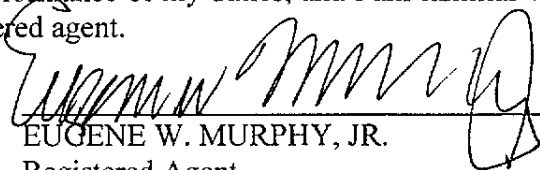
