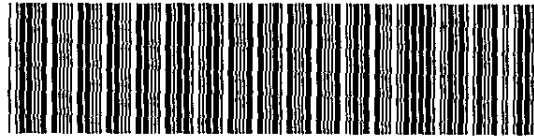

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms this corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is Mold Solutions, Inc.

ARTICLE II

ADDRESS

The street address of the corporation's initial principal office is 8920 Sunset Blvd., Orlando, FL 32836.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock. Each share shall have a par value of \$1.00.

ARTICLE IV

PURPOSE/NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida or of any other state, county, territory or nation.

ARTICLE V

SPECIAL PROVISIONS

This corporation shall exist perpetually.

The foregoing right of indemnification shall be in addition to any other rights to which any director, shareholder, officer or registered agent may be entitled as a matter of law.

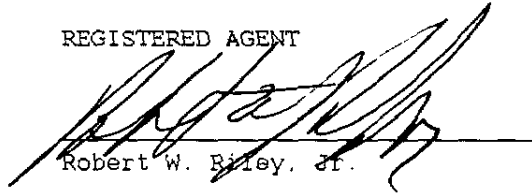
