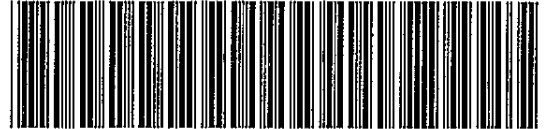



ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II - PRINCIPAL PLACE OF BUSINESS


