**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation shall be MAR-KY ENTERPRISES, INC.

**ARTICLE II**

The existence of the Corporation shall begin on October 7, 2004.

**ARTICLE III**

The purpose of the Corporation is to promote and facilitate recreational entertainment and to conduct all other lawful business.

**ARTICLE IV**

The address of the principal office of the Corporation is P.O. Box 12843, Tallahassee, Florida 32317-9607.

**ARTICLE V**

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$1.00 per share, all of which shall be Common Shares. All Common shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE VI**

The initial street address of the Corporation's registered office is: 234 East 7<sup>th</sup> Avenue, Tallahassee, Florida 32303. The initial registered agent for the Corporation at that address is: Michael Von Stein.

## ARTICLE VII

The initial board of directors shall consist of two members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one.
