ARTICLES OF INCORPORATION

OF

The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida does hereby subscribe to these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

SKINSPA OF NAPLES, INC.

The business of the corporation shall be carried on in Collier County, Florida, and at such other place or places in the State of Florida, and in the United States of America and foreign countries as may from time to time be authorized by the Board of Directors.
