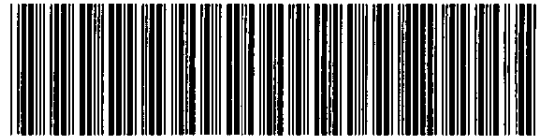



**ARTICLES OF AMENDMENT
OF
NEXGEN TRAVEL DISTRIBUTION, INC.**

The Articles of Incorporation of Nexgen Travel Distribution, Inc., a Florida Corporation (the "Company"), are hereby amended as follows:


A. The Name of the Company is: Nexgen Travel Distribution, Inc.

B. Paragraph 3(b) of the Company's Articles of Incorporation is hereby amended by deleting the first sentence thereof in its entirety and replacing it with the following sentence:

"The Corporation is authorized to issue 50,000,000 shares of Class B Non-Voting Common Stock."

The foregoing amendments were approved and adopted by the holder of 100% of the Company's Class A Voting Common Stock, on February 21, 2008. The number of votes cast for the amendment by said shareholder was unanimous and sufficient for approval.
