<u>ARTICLE I – NAME</u>

The name of this Corporation is:

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of theses Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of The United State of America and the laws of the State of Florida.

ARTICLE IV – CAPITAL STOCK
