ARTICLES OF INCORPORATION



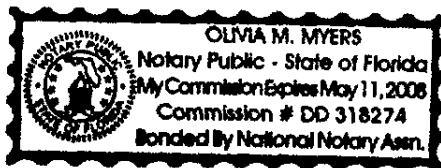
