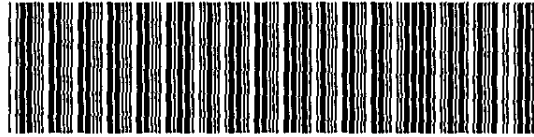



CAPITAL STOCK**


The corporation shall have authority to issue one hundred (100) shares of common stock, all of one class, one dollar (\$1) par value.



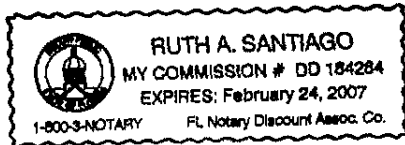
