We, the undersigned subscribers, are organizing a corporation for profit pursuant to the Statutes of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be Everybody Plays Sports, Inc., and the principal place of business of said corporation shall be at 22120 Little Lagoon Court, Lutz, Florida 33549.

ARTICLE II

The registered office of said corporation shall be in Pasco County, Florida, which address shall be 4603 Abdella Lane, Holiday, Florida 34690, and James Bandini, is hereby designated as the Registered Agent for service of process for said corporation at said address.

ARTICLE III

The purpose of the corporation is to engage in any activities or business permitted under the laws of the State of Florida or the United States.

ARTICLE IV

The corporation shall be authorized to issue Five Thousand and no/100 Dollars (\$5,000.00) in stock as follows:

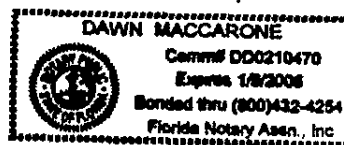

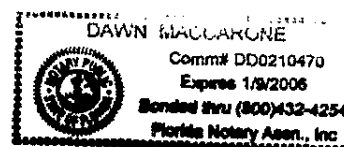
