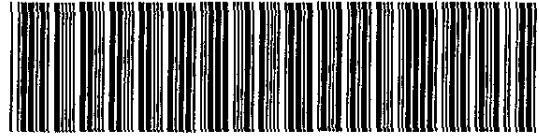

**ARTICLES OF INCORPORATION**  
**OF**  
**PINSEEKER, INC.**

**ARTICLE I**

**NAME**

The name of the corporation shall be: PINSEEKER, INC.

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

This corporation is hereby authorized to carry on and to license and authorize others to carry on any legal business in any other state as well as the State of Florida.

**ARTICLE III**

**CAPITAL STOCK**

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is FIVE HUNDRED (500) SHARES with a value of ONE (\$1.00) DOLLAR per share.

**ARTICLE IV**

**INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business shall not be less than ONE HUNDRED (\$100.00) DOLLARS.



**ARTICLE V**

**CORPORATION EXISTENCE**

The corporation shall have perpetual existence, which existence shall commence on the date on which these Articles are subscribed and acknowledged, unless the Articles are not filed with the Department of State within five (5) days thereafter, in which case such existence shall commence upon filing.

**ARTICLE VI**

**PRINCIPAL OFFICE**

The principal office and place of business of this corporation shall be located at: **107 Club Drive, Palm Beach Gardens, FL 33418** with the privilege of establishing offices and places of business at other places in the state of Florida or the United States of America or abroad.

**ARTICLE VII**

**DIRECTORS AND OFFICERS**



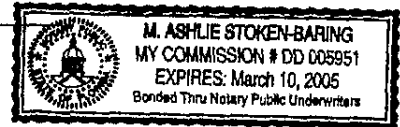
