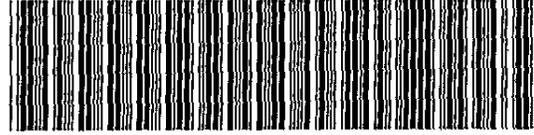

The undersigned subscribers of these Articles of Incorporation, natural persons competent to contract, do hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I  
NAME**

The name of this corporation is: European Art Glass, Inc.

**ARTICLE II  
PRINCIPAL OFFICE**

**ARTICLE III  
PURPOSE**

- A. The general nature of business or businesses to be transacted by the Corporation is:
