### Article VIII: Dissolution

The company is only dissolved by the Director, without the consent of any officer, and is complete once the dissolution is filed with the Department of State.

### Article VIV: Duties and Responsibilities of Officers/Director(s)

The Director is solely responsible for the daily operations and management of the company.
