#### Articles of Incorporation Continued

### Article VIII: Dissolution

The company is only dissolved by the CEO, without the consent of any officer, and is complete once the dissolution is filed with the Department of State.

## Article VIV: Duties and Responsibilities of Officers

The CEO is solely responsible for the daily operations and management of the company. The CEO has all the rights: to defend the company in any litigation or litigious matter—particularly by using the company's funds/assets WITHOUT the consent of any officer, to buy or sell the company's assets or property WITHOUT the consent of any officer, to purchase services and properties on behalf of the company WITHOUT the consent of any officer, to dissolve the company WITHOUT the consent of any officer, and to perform any other act by law. NOTE: This list in not exhaustive.

The CEO is responsible for managing the distribution of the capital gains, profits, and losses of the company.

#### Article X: Miscellaneous

The company is hereby classified as an "S" Corporation.

Any clause or article of the Articles of Incorporation can be modified, added, or deleted only by the CEO without the consent of any officer by filing the appropriate amendment with the Department of State. The company cannot be purchased by members of the public. It is not a publicly traded company but is a closely held corporation.
