

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE !

The name of the corporation shall be:THERAPEUTIC MEDICAL MASSAGE, INC.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE
