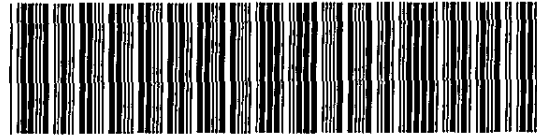

The name of this corporation shall be **231 PAINT & BODY SHOP, INC.**

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose of this corporation shall be to engage in operation of the business of paint and body work to automobiles to the general public and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.
