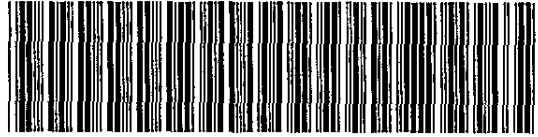

OF

The undersigned incorporator to these Articles of Incorporation, by these articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is Multisupply, Corp.

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activity permitted under the laws of the United States and Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is 5000, all of which shall be one class of common stock having a par value of \$ 1.00.

FIFTH. The address of its initial registered office is 3060 New York St., Miami, Fl 33133 and the name of the initial register agent at such address is Freddy Nava Granados.

SIXTH. The initial board of directors will consist of one director, whose name and address is Freddy Nava Granados, 3060 New York St., Miami, Fl 33133.

Preemptive Rights shall be as follows: each shareholder of stock of this Corporation shall be entitled to full preemptive rights to purchase unissued or treasury stock of the corporation convertible into or carrying a right to subscribe to acquire shares of any such unissued stock or treasury stock.
