



Pursuant to Section 607.1403, Florida Statutes, we, the undersigned, hereby execute and acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of Lakeline Properties Inc., a Florida corporation for profit organized under the laws of the State of Florida, to wit:

ARTICLE I - Name and Incorporation

The name of the corporation is LAKELINE PROPERTIES INC. (the "Corporation"), that was incorporated under Articles of Incorporation filed with the Florida Department of State on October 13, 2004 and assigned document number P04000141449.

ARTICLE II-Resolutions of the Shareholders
