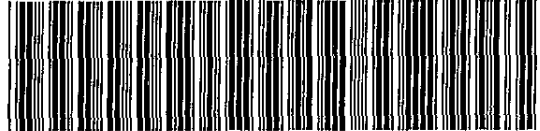

THE UNDERSIGNED, acting as incorporator of the Home's Solution, Inc, under Chapter 607 of the Florida Statutes, hereby adopts the following ARTICLES OF INCORPORATION for such Corporation:

ARTICLE I

NAME

The name of the Corporation shall be:

DURATION

The duration of the corporation is perpetual.
