**ARTICLES OF INCORPORATION

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Professional Corporation (the "Corporation") under Chapter 607 *Florida Statutes* and under Chapter 621 *Florida Statutes*.

**ARTICLE I  
Name and Address**

The name of the Corporation shall be **PHILLIP C. DOZIER, P.A.** The principal office of the Corporation shall be located at 1016 Lakeside Drive, Apopka, Florida 32712, unless and until changed by resolution of the Board of Directors.

**ARTICLE II  
Nature of Business**

The purpose for which the Corporation is organized is to provide personal services rendered by Attorneys at Law as permitted under the laws of the United States and the State of Florida.

**ARTICLE III  
Stock**

The authorized capital stock of the Corporation shall consist of 1,000 (One thousand and no/100) shares of Common Stock with a par value of \$1.00 (One and no/100 Dollar). 
