WE, THE UNDERSIGNED, being natural person(s) of legal age, hereby desire to form a corporation under the laws of the state of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be CENTRAL HOSPITALITY & DISTRIBUTION, INC., a Florida corporation. The initial principal place of business of this corporation shall be 7598 Currency Drive, Orlando, Florida 32809 and its mailing address shall be 7598 Currency Drive, Orlando, Florida 32809.

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation shall have those powers authorized or permitted by law or otherwise, it being the intention that this corporation shall have the right to engage in any business or activity not expressly prohibited by applicable law of the state of Florida.



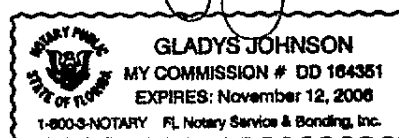
