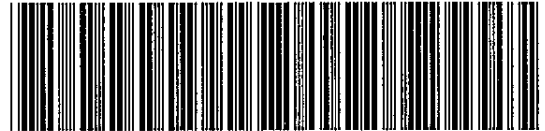



ARTICLES OF INCORPORATION

OF

USA CURRY GP, INC.

The undersigned, acting as the Incorporator of USA CURRY GP, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the *Florida Statutes*, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is USA CURRY GP, INC. The mailing address of the Corporation shall be 4051 West State Road 46, Sanford, Florida 32771.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE


ARTICLE VIII - BYLAWS


