ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

EFFECTIVE DATE

Pursuant to the written consent of the shareholder owning a majority of the issued and outstanding shares of stock and the Board of Directors of the Corporation, in lieu of a special meeting, which vote was sufficient for approval, the following resolution was adopted on December 12, 2012, amending the Articles of Incorporation:
