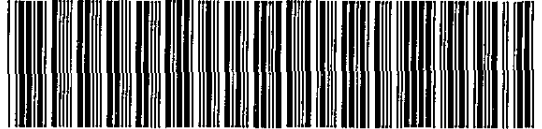

The undersigned for the purpose of forming a Sub Chapter S corporation under the Florida Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE

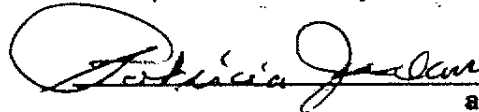

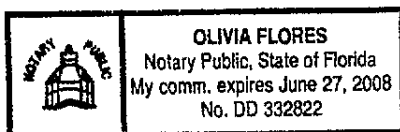

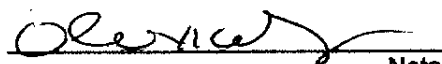
