- 1. <u>Name</u>. The name of the corporation is: CHRISTOPHER CRANDON, P.A.
- 2. <u>Purpose</u>. The corporation may engage in the business of carrying on the business of a real estate associate and rendering such professional real estate services; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
