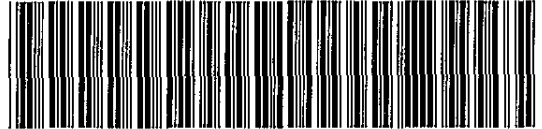

**ARTICLES OF INCORPORATION
OF
NATURE CLIPS, INC.**

The undersigned hereby associates for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute Chapter 607.

I.

The name of the corporation shall be:

NATURE CLIPS, INC.

II.

The principal office of the corporation and the mailing business address of the corporation shall be:

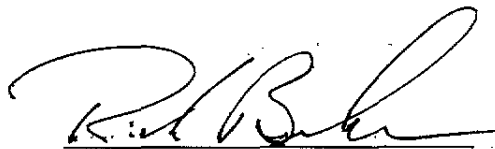
