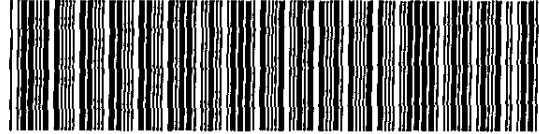

## ARTICLES OF INCORPORATION

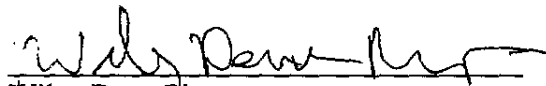
The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1) The name of the corporation is DnD Carpentry, Inc.
- 2) The address of the corporation is 1491 15<sup>th</sup> St. SW, Naples Florida 34117
- 3) The period of its duration is perpetual.
- 4) The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.
- 5) The corporation shall have authority to issue seventy-five hundred shares, all of one class, one dollar par value.
- 6) The name of its initial registered agent is Christian B. Felden and the address of its initial registered office is Orion Bank, 3838 Tamiami Trail North, Suite 416, Naples, Florida 34103.
- 7) The initial Board of Directors shall consist of two (2) members, who need not be residents of the State of Florida or shareholders of the corporation.
- 8) The names and addresses of the persons who shall serve as directors until the first annual meeting of shareholders, or until their successors shall have been elected and qualified, are as follows: Wiley Dean Piper & Denise Lynn Piper, of 1491 15<sup>th</sup> St. S.W. Naples, Florida 34117
- 9) The names and addresses of the initial incorporators are as follows: Wiley Dean Piper & Denise Lynn Piper, of 1491 15<sup>th</sup> St. S.W. Naples, Florida 34117
- 10) The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholder's meeting, with not less than a majority vote of the common stock.

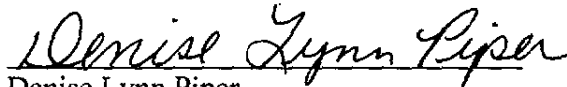

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
